



# **Long-Term Partnership Agreement**

# Article 1 - Nature of the agreement and parties to the agreement

The following document serves to detail how the partnership of the EU co-funded project "Web Accessibility and Other Initiatives for Persons with Disabilities in EU in Pandemic and Other Crisis Times" will continue to cooperate in the long-term. #### Article 2 - Networking themes included in the agreement

As this project was prepared for the call for proposals "Europe for Citizens; Strand 2: Democratic engagement and civic participation" of the Europe for Citizens Programme action "Networks of Towns", the partnership will continue to promote the themes and priorities identified in this call as well as other important themes identified during implementation.

The central themes identified and included in the agreement include:

- Communities response to rights of persons with disabilities in times of crisis:
- Promoting and improving digital content accessibility for persons with disabilities in almost all aspects of life (learning, public content, entertainment, professional development and employment, etc.);
- Continuing to organize workshops, presentations, conferences & site visits, creating new ties & demonstrating good practice through networking;
- Discussing the global nature of pandemic and any kind of crisis that affects all citizens but especially persons with disabilities in terms of accessibility or any other issue;
- Education for public, private and NGO sector during crisis, building solidarity in times of crisis;
- Developing accessibility actions for civil society, education for volunteers, what the EU agenda means for persons with disabilities;
- Volunteering to address the needs of persons w/disabilities, civil protection volunteering,
  promoting accessibility issues in the pandemic and other emergency situations;

- Informing and engaging citizens from different generations in democratic processes concerning rights of persons with disabilities;
- New concepts for persons with disabilities, going forward with new and innovative solutions and actions;
- Enhancing the capacities of citizens (and other target groups actively involved in civil society) to organize and lead actions as volunteers and community leaders;
- Improving education and training programmes and approaches regionally so that they promote citizen engagement for persons with disabilities;
- Creating the conditions for social inclusion in European communities in line with the principles of the EU Charter of Fundamental Rights;
- Enhancing citizen involvement in actions that combat climate change and promote sustainability;
- To enhance citizen awareness and understanding about fundamental European values such as diversity, mutual understanding, solidarity and social inclusion;

#### Article 3 - Means of networking between partners on the defined themes

The means of networking and further cooperation between the partnership include the following:

- Participation in events organized by the partners in their regions
- Transfer and exchanges of know-how by participating at seminars, conferences and workshops organized by the partners in their regions
- Collaborating with other projects of similar nature (resulting in mutual benefit for all partners taking part in the collaboration),
- Cooperating on the development of new projects and actions that build on the results of the project "WAI4PwDs".

# Article 4 - EU and international programmes and projects to consider for collaboration

The partnership agrees that the most effective way of building on the results of the project is through the development of new projects and actions that are co-funded via EU programmes. The EU programmes that best relate to this project are those that focus on social inclusion and all forms of accessibility for persons with disabilities and that can be accessed by all partners.

The programmes that shall be considered by the partnership include:

#### - EU community programmes

- CERV programme Entities from EU countries are eligible. The Republic of Serbia is expected to sign a memorandum of understanding and be included in the list of eligible countries.
- ERASMUS + Programme Entities from EU countries and Serbia are eligible
- HORIZON Europe Entities from EU countries are eligible
- Creative Europe Entities from EU countries and Serbia are eligible
- Transnational and Interregional programmes
  - INTERREG Central Europe Entities from the EU partner regions are eligible. Serbia is not eligible. Serbian entities can participate as associates only.
  - INTERREG Danube All of the countries in the partnership.
  - INTERREG Adrion All of the countries in the partnership, except Bulgaria can participate in projects. Bulgarian entities could participate as associates only.
  - INTERREG Europe Entities from the EU partner regions are eligible. Serbia is not eligible
  - European Commission International Partnerships Projects target third countries outside the Union, including Serbia, and can include Transnational partnerships targeting third countries.
